Vide letter No. E/74/26 dated 17.03.2026 the undersigned has sent proposal for enhancement of nomination fee detailed thereunder for the different posts, whereupon the Bihar State Bar Council vide letter in reference No. 808/26 dated 18.03.2026 issued under the signature of Learned Secretary, Bihar State Bar Council, such enhancement of nomination fee came to be approved.

Against letter No. E/74/26 dated 17.03.2026 C.W.J.C. No. 4393 of 2026 (Saroj Kumar Vs. the Bar Council of India & Ors.) challenged in the writ jurisdiction.

The matter was heard on 25.03.2026 as well as 26.03.2026 and it has been resolved after due indulgence of the Hon'ble High Court by the Members of the Bar present in the judicial proceeding that the proposal for every posts nomination fee should be slashed to ¼ which has been accepted by the Hon'ble High Court whereupon memorandum of understanding duly signed by all contesting parties has been filed.
